- Open to all artists and works are subject to all guidelines as outlined below, submitted as 8" x 10" prints only and received by November 4, 2007. Prints will not be returned.
- Identifying information must be indicated on the back of the print: Artist, Title, Size, Medium, Price and Entry Number.
- Art work entries can be delivered in person on November 2, 3 or 4.
- CAL reserves the right to refuse any entry not accurately represented by entry image(s) or not suitable presented for exhibition.
- Images for Juror must be 2-D: All including: oil, acrylic, prints, watercolor, drawings, pastel, mixed media, photography, fiber, metal, jewelry, ceramics and graphics.
- All 2-D works must be suitably framed, no clip on glass and/or Plexiglas frames accepted.
- 3-D: All including: sculpture, bas-relief, textiles, pottery, jewelry, ceramics, mixed media & wearable art.
- Art work must be able to pass through a standard size door.
- If any work requires more than one person to move, the artists must provide assistance for installation.
- Art work cannot have won a prize in any previous CAL show.
- Artwork must be original and not copied.

Entry Fees – No Limit on the Number of Entries

- CAL Members entry fee is \$10.00 for the first entry, \$5.00 for each subsequent entry.
- Not a CAL Member then the entry fee is \$15.00 for the first entry, \$7.50 for each subsequent entry.
